Residency publications

The resident has to be the *first author of at least one original article out of the required two.*

The two articles must have been published or accepted for publication in a peerreviewed international journal before March 1st of the application for the examination year.

One article may be a case report with literature review, an evaluation or validation of diagnostic methodology or technology in clinical pathology, a retrospective or prospective study of clinical pathology changes in a disease or toxic state, or a pathophysiological study of clinical pathology changes.

Even a case report can be a first author publication.

Which residents are eligible for this new rule?

This is valid for those who apply to sit the examination in 2018

<u>Action</u>

It should be corrected at the Information brochure, the EXAM APPLICATION CHECK LIST Document ID: 3.2 (found at the Info Centre of Exam and Cred Committees).

Case reports – good news, not required

Previous Information Brochure: "After the 2nd year a case-book of in depth case summaries describing one case each in haematology, biochemistry and cytology where clinical pathology was a major contribution to diagnosis) and an essay on problem solving addressing topics relevant to general clinical pathology (e.g. QC assessment, method development or validation) should be prepared."

No case reports should be submitted to the CC for evaluation before the exam.

Supplemented materials during residency training period

It should be clearly stated in the Information Brochure that the Resident programme lasts for defined periods which should be accepted by the Education Committee.

Examining appropriate number of cases and preparing publications are the parts of the residency training programme, these should be examined and prepared during this period, and not before.

The publications should be prepared during the training period.

Supplemented materials during residency training period

It should be clearly stated in the Information Brochure that the Resident programme lasts for clear periods which should be accepted by the Educational Committee.

Examining appropriate number of cases and preparing publications are the parts of the residency training programme, these should be examined and prepared during this period, and not before.

Equivalent clinical practice-Update

One of the prerequisites for a residency candidate is: "a 1 year rotating internship programme, or 2 years in veterinary practice, or equivalent clinical practice acceptable by the Credentials Committee"

Two of the candidates (Giessen and Toulouse), whose clinical practices have been evaluated.

In the case of both candidates their previous clinical experience/practice was considered acceptable by the CC.
