

In 2012 our annual meeting in Ljubljana (Slovenja), was a great success not only from an economical perspective but also in term of participation and the quality of the presentations. The collaborative meeting with ISACP allowed us to strengthen the relationship between our two societies and to have invited lectures at the highest level. I wish to thank the local organizing committee for their great capability and the skill shown in putting on such a successful meeting. I really enjoyed it! In the ESVCP Annual General Meeting I presented the results of the online survey on clinical pathology in Europe. You can now find a comprehensive report on the ESVCP website with some comments regarding possible future plans to improve society's visibility and strengthen us going forward.

The society was also involved in two other meetings this year: the first workshop on canine lymphoma held in Lugano on June 22nd 2013, and an ESVCP session at the ECVIM congress in Liverpool, Sep, 14th 2013. They were a great success in term of participation and quality of the presentations and also helped to create collaborations between researchers working in the same topics but in different fields.

The next annual congress is going to be held in Berlin in November, 6-9th 2013 and you will find a complete program and more information in the present newsletter. I wish to thank our vice-president Stephan Neumann for the great efforts he has put into the organization of this upcoming meeting.

Thanks to the society's good economic health we were also able in 2013 to assign an ESVCP Small Research Award (ESVCP SRA) to support a resident research project: Barbara Ruetgen, University of Vienna: Title: The establishment of analyses for assessment of molecular clonality in feline lymphoma. The society also awarded prizes for the best poster, scientific communication and case presentation at the Ljubljana meeting. We wait now for the results of the research the society has supported in the last few years and I'm sure that we will be very glad for our choices. One of those we have supported in the past is presenting at the meeting in Berlin this year.

Finally, I want to thank you all for the renewed trust in our society and to remember that the regular payments of the annual fees is mandatory for regularly receiving the journal and, for ECVCP diplomats, to maintain their status.

LETTER FROM THE ECVCP CHAIR

Dear Colleagues,

This is my last message as the ECVCP President. Procedures for the election of the new ECVCP Board have already started and will be completed by the next ECVCP meeting at the Berlin Congress. Therefore, it is time to briefly summarize the activities of the past three years, with special emphasis on this last year.

In 2011 the ECVCP Committees were restructured and enlarged, and a Secretariat post was established (I still recommend any member to interact with the Board or the Committees through the address secretariat@ecvcp.org,)

In 2012 the procedures for a more efficient communication among ECVCP Committees and between the ECVCP Committees or Board and college membership were established and the connections with the ASVCP increased, with the creation of a "task force" to work towards a possible harmonization of our training procedures.

Also in 2012 the College passed the 5-year EBVS recertification.

In 2013 the role of the Secretariat was further expanded, largely thanks to the recruitment of Sue Lennon to the position. The ECVCP/ESVCP website has been refurbished in order to be more user friendly. Once this process has been completed it will be easier to find and download relevant documents and forms.

July 19th to 23rd 2013 saw us hosting our first summer school in Porto in July, jointly with the summer meeting of the ECVCP Board and Committee chairs. Eighteen Residents participated in the summer school with lectures and practical sessions on the four parts of the exam and a self assessment test that was held on the last day. Their comments about this experience were enthusiastic and this is on one hand a great satisfaction for the Board and on the other hand a stimulus to plan further similar educational initiatives in the future. I take this opportunity to thank, both personally and on behalf of the Board, the teachers that prepared lectures, slides, cases, workshops, and especially to three members of the summer school committee, Gabriele Ghisleni, Emma Hoojberg and Nazarè Pinto da Cunha that were the main individuals involved in making this a successful experience.

Finally, the ECVCP has been registered as a Charity in UK. This step was necessary for legal and fiscal reasons and will allow us easier management of some of the College's activities. Nevertheless, this requires a change in the Constitution that must include some articles related to the general regulation of UK charities. Although the parts of the Constitution related to practical issues of the college's life (membership, composition of Board and committees, exam rules, etc) are not changed, the new Constitution needs to be approved at the next AGM. Therefore it will be circulated by email as soon as possible to allow the membership the opportunity to check and comment on the modifications before voting.

Also the information brochure (IB) has been revised to comply with EBVS rules for standard and alternative programmes (including supervision/cosupervision of programmes) and to satisfy the EBVS recommendation to facilitate the creation of new Residency programmes and future residents ability to access these programmes to maintain an adequate level of training quality. The new IB will be presented at the next AGM in Berlin and then published on the website. As stated in the previous newsletters, the IB needs to be continuously updated, being a "dynamic document" that must be adapted to any current problem or EBVS recommendation. Therefore it is particularly

important that ECVCP members regularly check the IB published on the website, especially before applying for the accreditation of a laboratory or of a training programme.

I want to personally thank the Board members, who supported all the activities of 2013 and of the whole of my 3 year term. The committee members and especially the committee chairs (see the website for the composition of Committees) that dedicated a lot of time and extra-hours to their Committee, and all the diplomats that provided suggestions or comments that facilitated the work of the Board and Committees.

Despite this large amount of work, other aspects of the College's life still need to be improved in the future. The promotion and protection of the title at a National and European level and the possibility to increase our critical mass through the possible inclusion of other subspecialties that are scientifically closely related to Clinical Pathology (as outlined by many ECVCP/ESVCP members in the survey presented in Lubjliana and recently published on the website). Therefore, it is important that the next elections will involve as many ECVCP members as possible, to give to the new Board a strong support from the membership. I strongly invite all the ECVCP members to participate to the electronic ballot that will be open as soon as possible and will be concluded immediately before the next AGM.

The next meeting in Berlin will be a great opportunity for a successful scientific meeting but also to be informed about all the news mentioned above, to approve the new Constitution, to welcome the new diplomats that passed the exam in 2012 (Myriam Defontis, Anne Geffrè, Emma Hooijberg and Josefine Oberg) and to meet the new Board. Therefore, I'm looking forward to seeing you in Berlin.

Call for questions for the ECVCP examination & SUBMISSION FORMS

Dear ECVCP member,

According to the ECVCP constitution and By-laws, all diplomates must submit five questions, along with their fully-referenced answers, each year (by June 30th) to the examination committee. Failure to submit questions for two consecutive years can cause suspension of approval of training programs. They are also a requirement for maintaining diplomate status.

Late submission of written questions results in inconvenience to the section leader and extra mailings of segments for review. The task of preparing all items for various sections is sizable. To meet deadlines, we ask that diplomates provide the highest quality items. We encourage everyone to start assembling materials as soon as possible to avoid last-minute rush preparations.

Please provide multiple choice question and essay questions to be chosen among the following: Biochemistry cases, cytology or haematology images or glass slides.

All the questions must have correct and incorrect options and include one or more references to support correct responses and provide explanations as to why the incorrect responses are incorrect. With an essay question, a written response worth 10 to 20 points must be included with suggestions on the breakdown for grading the different portions of the answer provided.

There is a guidance document for you to follow in preparing your questions. Please use this guide to ensure your questions can be accepted.

There is no guarantee your questions will be used in the examination. Questions will be reviewed for acceptability.

2012 EU Veterinary Clinical Pathology Survey

Stefano presented the results of a survey conducted in 2012

- · 54 responses were received
- · The largest number of respondents were in academia with lesser numbers in commercial laboratories, industry and private practice
- · More than half the institutions had one-or less ECVCP diplomate
- · More than half had 1-5 five non-diplomates and residents
- · The largest number of respondents listed Cytology as their particular expertise with less for Haematology and even less for Clinical Chemistry
- · The majority of respondents felt that the awareness in other veterinary specialists of the role played by Veterinary clinical pathologists was "Poor" or "Insufficient"

A detailed report of the survey will be made available on the college/society website.

Other matters

Stefano highlighted the need over the coming year for the society to focus on the following procedural matters:

- · Establishment of procedures for organization of the scientific meetings, including composition of scientific committee and inclusion of a member of the board in local organizing committee
- · Setup of a post meeting survey to collect:
- Comments, criticisms and suggestions from people who attended the meeting
- o Comments from members who decided not to attend the meeting
- · Guidelines for awards assignment
- · Guidelines for reimbursements for invited speakers

Report of the Treasurer and Auditors

In the absence of Mark Pinches, the report of the treasurer was presented by Peter Graham and Stefano Comazzi

Membership numbers and fees

- · Membership numbers had increased to 217 a 26% increase on 2009 numbers The main issue of concern was the proportion of Members that had not yet paid their 2012 subscription in the first 6 months of the year. The meeting was reminded:
- · Subscriptions for *Veterinary Clinical Pathology* including annual refresh of online access will not be processed until membership fees are received and that there is no guarantee that back-issue can be organized for late-payers.
- That all diplomates of ECVCP are required to maintain a fully paid membership of ESVCP *Costs associated with Meetings*

It was noted that considerable society funding support had been necessary for the most recent Dublin meeting.

Account balances

Despite the late payment of subscriptions this year, the society remained in a strong financial position and would be easily be able to continue to fund the Small research Grant scheme

Elections of vice-president, secretary and treasurer and Auditors

The positions of Vice-president, Secretary and Treasurer were available for election.

Notifications of the elections and requests for nomination were distributed to the meeting in advance of the meeting.

Single nominations were received for each post:

- · Vice-president: Stefan Neumann
- Treasurer: Mark Pinches (additional term)
- · Secretary: Kate English

All three nominations were confirmed as elected by unanimous show of hands.

The current Auditors were re-elected unanimously

Thanks were given to Peter Graham for his 9 years of service as Society Secretary

Report of Next meetings

Stefan Neumann presented information concerning the next meetings of the society:

Report of Journal of Veterinary Clinical Pathology

Karen Young provided an overview of the activities of the Journal of Veterinary Clinical Pathology over the last year (The official journal of both the American and European Societies of Veterinary Clinical Pathology)

- · 224 new manuscripts
- · 29% acceptance rate
- · 50% rejection rate
- · Average submit-accept interval 136 days
- Impact factor (2011) = 1.556
- o Reflects citations of articles published in 2009 and 2010
- o 26% increase 2010 (1.239)
- o 96% increase over 2009 (0.793)
- o Ranked 31 of 143 veterinary journals (was 44 of 145)
- · Published ESVCP, ASVCP, ESVCP at ECVIM abstracts

- \cdot 50% of manuscripts were Original Research with lower proportions of What's-Your-Diagnosis, Brief Communications and Case Reports
- The US and Europe represented the most submitted manuscripts at 28-29% each. Asia and South/Central America accounted for almost all of the remainder in equal proportion.
- · Author guidelines reflect a need for compliance with reporting guidelines (STARD, CONSORT, REFLECT and ARRIVE)
- · iThenticate Plagiarism checking has been implemented in the journals review processes.
- · Thanks was given to the editorial board and section heads and more than 200 reviewers that have contributed to the success of the journal this year
